PUBLICATION OF AMENDED 2022/23 INTERGRATED DEVELOPMENT PLANNING (IDP) AND BUDGET PROCESS PLAN

In terms of Section 28 (3) of the Local Government: Municipal Systems Act 32 of 2000 (as amended) read with provision Section 21 of Municipal Finance Management Act No.56 of 2003, municipalities are required to outline key dates/deadlines for preparation of the IDP and Budget. Due to the Local Government Elections that have taken place on the 01 November 2021 and the newly elected council inaugurated, Amahlathi Local Municipality Council has adopted the Amended IDP/Budget Process Plan for 2022/2023 financial year on Tuesday, the 7th December 2021. The Process Plan contains key dates/ deadlines and budget timelines that will be guiding the drafting of the IDP Review and MTERF budget formulation.
