INVITATION FOR NOMINATIONS FOR PERSONS TO BE APPOINTED AS MEMBERS OF THE AMAHLATHI LOCAL MUNICIPALITY MUNICIPAL PLANNING TRIBUNAL

Amahlathi Local Municipality hereby invites nominations for members of the public to be appointed to serve as members of Amahlathi Local Municipality Municipal Planning Tribunal (ALM:MPT) in terms of Section 33 of Amahlathi Local Municipality Spatial Planning and Land Use Management by-law, 2016 read together with Section 35 (1) of the Spatial Planning and Land Use Management Act; 16 of 2013 (SPLUMA). Term of Office: The period of office of members will be five (5) years calculated from the date of appointment of such members by the Amahlathi Local Municipality Council.

Nominees must be: Registered professional Town Planner, Registered Advocate/Attorney; Registered Environmental Specialist; Registered Civil Engineer/Structural Engineer; and must have knowledge and experience of spatial planning, land use management, land development applications, and legal aspects in respect of the built environment and other related areas of specialisation.

Each nomination must be in writing and must contain the following information:

- a) The name and address of the nominator, who must be a natural person and a person may nominate himself or herself;
- b) The name, address and identity number of the nominee;
- c) Motivation by the nominator for the appointment of the nominee to the Amahlathi Local Municipality Municipal Planning Tribunal (not exceeding one (1) page);
- d) A curriculum vitae of the nominee (not exceeding two (2) pages);
- e) Certified copies of qualifications and registration certificates indicating registration with the relevant professional body or voluntary association.

It must be noted that nominees will be vetted before appointment is made.
